

Request for a Site Visit

NOW COMES the Town of Calais Selectboard (“the Town”), by and through its counsel Stitzel, Page & Fletcher, P.C., and hereby requests a site visit be held in conjunction with the above-captioned docket concerning a proposal for the development of a wireless telecommunications facility at 1056 Bayne Comolli Road in Calais, Vermont, on property owned by Steve Perkins (“the Project”).

The parties have informally discussed the proposal that the site visit be held the morning of the hearing or a nearby prior date, but, absent knowledge of when this hearing and other Public Service Board hearings will be scheduled in early October, the parties do not have a final date to propose. In the alternative of the parties requesting a specific date today, the Town requests that the scheduling of the site visit occur simultaneous to the scheduling of the hearing.

If a specific date is needed, the Town suggests that a site visit be held the morning of the hearing but that it is scheduled prior to the hearing and in such a way that it allows for an hour and a half of on-site discussion but does not interfere with the time allotted for the hearing. If the hearing time would necessarily be

shortened to accommodate the site visit should it be scheduled for the same day,
the Town requests that the site visit occur prior to the hearing on a separate day.
